In addition, I understand that until my past due balance is paid, my child(ren) may be prohibited from attending class and/or participating in school activities such as class trips, grade-level events and graduation.

I agree to pay, to the extent permitted by law, the school's expenses of enforcement and collection of tuition, fees and related expenses including, without limitation, attorney's fees and costs. The laws of the Commonwealth of Massachusetts shall govern this contract. I understand if enrolled in FACTS, that FACTS will assess a returned item fee for EFT's not honored by the bank.
